VETERINARIAN APPROVAL IS REQUIRED FOR ALL ANIMAL IMPORTS AND EXPORTS. ALL ANIMAL IMPORTS AND EXPORTS ARE COORDINATED BY CLAMC.

Because animals that carry diseases can jeopardize valuable animal colonies at our institution, animals from nontraditional vendors must be quarantined. Approval for shipment of rodents will be granted if the originating colony is negative for the presence of pathogens of concern based on sentinel health reports requested from the sending institution. Incoming nontraditional vendor rodents must be quarantined and tested for specific pathogens before they can be used. The quarantine and testing process usually takes 7 weeks. PLEASE CHECK THE CLAMC WEBSITE FOR UPDATED FEES FOR IMPORTS AND EXPORTS.
